

The Rewards of Reuse

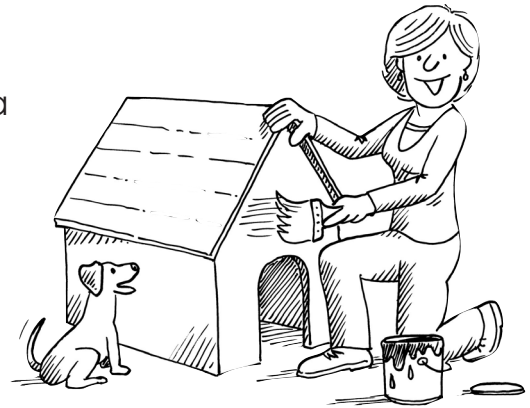
Send us a photo of your project and be eligible to win a \$25 Visa Gift Card.

Participants may enter up to five times each contest period (May 1- October 31; November 1- April 30).

To be eligible, participants must be at least 18 years of age and have completed a **product reuse liability form** when obtaining product. Complete contest rules are printed on the back of this form.

Description of Contest/Participation.

A. Dates of Contest: Two contest periods will be held annually. Contest will begin on or about May 1 and end on or about October 31 annually; contest will begin on or about November 1 and end on or about April 30 (“Contest Period”). WLSSD reserves the right to terminate the Contest at any time, without public notice of termination.

B. How to Enter: Enter by first visiting the Product Reuse Center and taking home free product for reuse. You must complete the Product Reuse Center liability form to be eligible to win; product must have been obtained on May 1, 2010 or later. Submit a photograph of your project, accomplished using items obtained at the Product Reuse Center, along with the completed “Reaping the Rewards of Reuse! Contest Entry Form.” The deadline for registration is the end date of the Contest Period. Valid contest entries must contain all information requested and must be received by at the Western Lake Superior Sanitary District by email, in person, or via mail on or before the deadline for registration. Limit five (5) entries person. One entry per photographed project, each project must be a distinct work. Incomplete entries and/or entries beyond the limit of 5 will be disqualified.

All entries become the property of WLSSD and will not be returned. WLSSD is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties and other technological problems. WLSSD is not responsible for lost, late, illegible, misdirected, mutilated, postage-due or incomplete entries or mail. The website administrator’s computer will be deemed the official time keeping device for the Contest promotion. Contest entries must contain all information requested and must be received on or before the deadline for registration to be deemed valid.

Photographs of entries and the text submitted with the entry form as “Project Description” will be posted for public view at the WLSSD Household Hazardous Waste Facility, 2626 Courtland Street, Duluth MN 55806.

Entries may be submitted electronically (jpeg photographs only) to hhw.reuse@wlssd.com, in person at the Household Hazardous Waste facility, or via mail to the address listed above.

By participating, all winner(s) grant WLSSD exclusive permission to use their names, characters, photographs, voices, and likenesses, as well as those photographs submitted in the contest entry, in connection with promotion of this contest and waive any claims to royalty, right, or remuneration for such use.
